Q1: What are the Prohibited Uses/Unallowable Costs for Byrne SCIP funding?

**A1:** Refer to the Program Information page of the application under "Prohibited Uses" and the link to the DOJ Grants Financial Guide, Section 3.13. Additionally, as of August 18, 2025: Any obligations of funds, at any tier, under this award to provide (or to support the provision of) legal services to any removable alien or any alien otherwise unlawfully present in the United States shall be unallowable costs for purposes of this award, but the foregoing shall not be understood to apply—(1) to legal services to obtain protection orders for victims of crime; or (2) to immigration-related legal services that may be expressly authorized or required by any law, or any judicial ruling, governing or applicable to the award.

Q5: Are there any specific requirements for programs funded under Byrne SCIP?

**A5:** 1) Adult drug courts funded under Byrne SCIP must be operated based on the 10 Key Components for Drug Courts. More information can be found at <a href="https://bja.ojp.gov/program/adult-treatment-court-program/resources">https://bja.ojp.gov/program/adult-treatment-court-program/resources</a>.

2) Any behavioral health crisis care program funded under this award must be in accordance with the Substance Abuse and Mental Health Services Administration (SAMHSA) National Guidelines for Behavioral Health Crisis Care. More information can be found at National Behavioral Health Crisis Care Guidance | SAMHSA Library.

**Q6:** Can Byrne SCIP funds be used to fund FTE to staff a school resource officer in a school where the SRO position was eliminated through budget cuts? This is not an inquiry about training for SROs, but a question of if these funds can be used for SRO salary.

**A6:** Byrne SCIP funds cannot be used to fund SRO salaries.

**Q7:** As this grant is a two-year period, what is your preferred method for receiving two years of budget or budget narrative? Would it be beneficial for us to submit budget items delineated by year? And to denote any year 1 vs year 2 changes within the budget narrative?

**A7:** The budget line items should be submitted in Amplifund for the total project budget under each line item. The budget narrative can break line items down by year.
